Minimum length charged 5m (all boats). Boat length is measured overall including davits, bowsprits, sterndrives, bathing platforms etc, rounded up to the nearest 0.1m. Dinghies and tenders must be stored aboard the vessel. All mooring fees are payable in advance. Any fees not paid in advance of the commencement date will incur an administration levy and will be charged at the temporary seasonal berthing rate.
